I have just a few comments regarding the minutes:

Subject: RE: Minutes from today's 60th Reunion Meeting

- <u>8b</u>: As indicated in an earlier email, I do not think that we had a consensus that the Classes of 1960 are going to pay for widows (but, I could be wrong). My suggestion is that the registration fee be waived for them; that they pay for whatever package they select.
- 2. <u>2d</u>: I think we determined that 2:15-2:30 PM Tuesday until 3:15 PM or thereabouts is when Jack Reardon would speak. We need to leave time for the small special interest (Owl Club, sports teams, et al) group gatherings. There isn't a lot of time with the Class photo being at 4:30 PM (or 4:45 PM) ... and with lunch starting a little later than Noon, given that we have the tours scattered about In the morning. I'm thinking that the small special interest group gatherings are better immediately following lunch so that, if they wish, they can incorporate lunch time as well (and this is a better time for the Chorus to rehearse -- by the way, we need to reserve Holden Chapel for the rehearsal) ... and that Jack would be better at 3:30 PM or thereabouts; but I realize this may not work for Jack.
- 3. <u>2g, 3bi and 3bii</u>: Aren't the "hospitality suite", the "conference/HQ space" and "hangout space" all the same? We should use just one term; I prefer "hospitality space". And, isn't this space to be available throughout the reunion ... and be "centrally" located?
- 4. <u>5g</u>: Tuesday night after dinner might be a good time to have this ... if we are going to have an open mic night. Note: Wednesday night is also possible, but there is the conflict with the Harvard Band and Glee Club concerts.
- 5. <u>5h</u>: Heidi Fiske, Carol Schein Gill and Margaret Armstrong Bancroft are the correct names.

- 6. <u>5i</u>: You can't discuss Harvard admissions policy/process/recent revelations (for example, regarding legacies, athletes [relative SAT scores, etc.; graduate students with eligibility, fake athletes, etc.], donors [the fencing coach, Epstein, donors in general], without discussing the lawsuit involving Harvard's alleged discrimination against Asian-Americans. Note: This topic could be broadened to include other discrimination issues (unionization of graduate student assistants, sexual harassment, etc. ... OR why is Harvard constantly in the news and not always in a good way?!?
- 7. <u>6a and 6b</u>: I think that Will Donham (not Elizabeth Sisson) is who we determined would do the Allston Campus Tour/Presentation. I think Liia was going to follow-up with Elizabeth Sisson regarding Harvard's Big Data (sic?) project. In general, we need to discuss a number of other tour possibilities such as newly renovated houses, Smith Campus Center, energy-neutral house near William James Hall, the innovation labs, the Engineering School, American Repertory Theater, etc. etc.
- 8. <u>**9aii**</u>: The Harvard Class of 1960 is not going to pay the hotel's parking fee for those staying at the hotel, especially in that it is possible to park your car during the reunion at the Business School and get a ride to/from the hotel.

Here is the summary I promised to write about yesterday's extended discussion about ideas for our program.

You can decide if Liz should incorporate this into the minutes, or send it out as an addendum to the minutes?

The Committee reviewed the list of proposed topics from Classmates for our Reunion program and eliminated ideas that would involve a talk by an expert and others that would not meet our goal of ' informal discussions, focused on our Class, and dealing with issues relevant to our current stage in life'.

We have two time periods on Wednesday for the program: 9:00 am - 12:15 pm and 1:30 pm - 3:45 pm

Sienna has recommended not to have concurrent sessions, so we have settled on four topics for these time periods,

with times to be decided:

 - Will ask Heidi to lead planning for this discussion. We've proposed a panel of 4-6 classmates
 - and then possibly 4 'breakout' sessions.
 - We believe will this will be a popular topic and the smaller groups will allow more individualized discussion,
 - especially if Radcliffe women want to address their unique concerns.

I've arranged the sequence arbitrarily, but we did agree that topic #4 should be the last one in the afternoon.

We also agreed that we could ask Jack Reardon to speak after Tuesday's lunch, at 2 pm. The 'free' time after his talk and before the 5:15 Memorial Service would allow the choir to practice, and any other 'special interest groups' to get together.

The "open mike" idea might still be possible to schedule as 'entertainment' for one of our other events?

I do not see anything else in the minutes that needs correcting. Will be traveling to NYC for an extended weekend, so will not be reading e-mail after today. Glad we had such a productive meeting yesterday! Hope the 'budgeting' session today went well, and everyone has an enjoyable weekend! Liia

So, Liia, did you not see my suggested changes etc. to the minutes drafted by Liz? I haven't heard from anyone else either.

(Did Carol get married again recently? I wasn't aware she was using Deitch; I think of her as Gill ... and I notice her email address is [REDACTED]

At any rate, with regard to your summary of the discussion topics, I would add that it appears that we have time for only three discussion topics during the day on Wednesday. I come to this conclusion in thinking about the realities around the time we have and also about the time required for topic #4.

My recommendation would be to have topic #4 in the afternoon, starting at 1:45 PM (not 1:30 PM; the time for getting people moving and moved is considerable) and ending at 3:30 or 3:45PM (we do need to allow considerable time for people to collect themselves and get to the Boston Childrens' Chorus concert). Remember, as you have outlined it, topic #4 unfolds in two parts: a panel presentation, followed by small group discussions (with a time in between for implementation of the logistics). As an aside, my understanding of topic #4 is more toward "change ... or lack of change ... in reflecting upon expectations held in the 1950s/1960s vis-à-vis the actual life experiences". I don't think the focus should be on the 50s and 60s; but, instead, on the change(s) that have impacted my life and continue to affect me today. More emphatically, I suggest that you drop the notion that the Radcliffe women have unique concerns; we all have unique concerns (or we all share the same concerns).

The other two topics could fit in the morning, especially if we do, in fact, start at 9:00 AM. The first topic could go until 10:30AM and the second topic could go from 10:45 AM until 12:15 PM.

Topic #1 (current issues at Harvard) intrigues me, but I am not sure that anyone from the Harvard administration is able to be candid enough to be effective as a leader of the discussion. Yet, I think it is a worthy topic; almost every day there is another awkward revelation about what goes on at Harvard. And, perhaps there are a relatively few classmates who really care about Harvard's problems today. Maybe it would be better to frame this topic as the extraordinary changes in the student body, how students spend their time, teaching methodologies, even the nature of the College in the University setting, etc.

On other matters, I previously suggested switching around the timing of Jack's talk and the period for the small special interest group sessions. I also agree that the open mic experience is best done after dinner either Tuesday evening or Wednesday evening.

Hi Bob -

I fully understand where Robbie is coming from. In thinking about his perspective on the preperformance and performance schedule, a 4:30 PM performance time (versus a 4:00 PM performance time) just doesn't cut it.

So, how about considering shifting the BCC performance to the venue of the clambake? My limited understanding of the clambake venue is that it is probably, unfortunately for the BCC, a tent somewhere in Harvard Yard or by the Science Center. If we pursue this, Sienna will need to chime in here and let us know what sort of venue options -- that is, venue options more conducive to the BCC's performance -- there might be.

Another consideration, in thinking about the schedule is that the Harvard Band and the Harvard Glee Club (HGG) are performing starting at 8:00 PM Wednesday evening; we have, thus far, included this event as a reunion option. So, do we want to juxtapose such similar events as the BCC and the HGG?

I also think that the idea of stretching the afternoon discussion session(s) beyond 3:45 PM is problematic. I agree with Bob's point about the attention span of many of our classmates being limited, especially in the context of 5 hours (9:00AM - 12:15PM and 1:45PM - 3:45PM) of discussion groups already being scheduled for Wednesday. (Perhaps we need to be more
